This means that no one is classifying anymore any entities. The database is not accessible any more. There are no paid clients to the company or service or database. It is all closed down. Ceased trading. This company is a ghost. Dormant. This email address and the website will also be shut down very shortly.

However, it remains that "Accredibase is a subsidiary of Verifile Limited" and under UK Law Verifile is legally responsible for the current operations of Accredibase, and there is no doubt that someone at Verifile can take down the concerned pages before the end of 2014.

Absent of such action by 02 June 2014, EUCLID will have no choice but to proceed with the escalation options against Verifile as parent holding company whose operations continue to be fully and publically integrated with the Accredibase database:
